Now let me take you through the inroads made by our **Project Jagruti** – initiated in 2010 at Tiware, Karjat Taluka, which supports the holistic development of underprivileged rural communities. Project Jagruti reaches communities through three major programmes across Community Centres operating from Tiware, Kadav & Kashele villages in Karjat Taluka, Raigad District & in Pokharan, Thane District. In November 2016, we initiated a new community centre at Kashele, Karjat Taluka, Raigad District to reach out to 40 villages in interior areas. The details of inroads made under Project Jagruti are highlighted separately in the executive summary which is a part of our **Annual Report 2016-17**.

It is only with your unflinching & unconditional support that we could raise ₹ 54,23,732/- for the 2nd consecutive year at the Standard Chartered Mumbai Marathon 2017. It was your benevolence and whole hearted support which made me the 3rd highest fundraiser and I was felicitated on behalf of LOLT by actress & sportswoman Ms. Gul Panag.

Executive Summary

Light of Life Trust a non-governmental organization established in 2002 and registered under Bombay Public Trust Act, 1950 is founded by Villy Doctor, with a strong belief that roots need to be strengthened and nurtured to grow healthy plants, so, we strengthen our roots, the rural people of India.

Vision: Transform the lives of underprivileged rural communities in India.

LOLT Project

1. Project Anando – (Education): initiated in 2005 with 25 children, the project supports underprivileged rural children to complete their secondary education as well as their all-round development. Over the years, it has impacted 10559 children & 110 teachers directly and 56447 community members indirectly across more than 520 villages. Additionally 540 beneficiaries have been favorably impacted in Thane, through educational activities.

2. Project Jagruti – (Community Development): initiated in 2010 at Tiware, Karjat Taluka supports the holistic development of underprivileged rural communities and has reached out directly to more than 27000 beneficiaries through three major programmes across community centres operating from Tiware, Kadav & Kashele villages in Karjat Taluka, Raigad District & in Pokharan, Thane District as under:

- ▶ Livelihood Training: operational since 2010, provides training to underprivileged rural women, girls & youth to help them attain financial independence. 2632 persons have benefitted from these training programmes since its inception.
- Healthcare: The Medical Mobile Unit is in operation since July 2013 and covers remote areas without adequate health care facilities. Since inception it has reached to 22828 patients & beneficiaries across 65 villages in Karjat Taluka, Raigad District, Maharashtra.
- Environmental Conservation & income generation: initiated in 2015, the program focuses on supporting poor farmers with an additional income through the distribution of fruit bearing plants. So far 2205 farmers from 53 villages in Karjat & Uran Taluka, Raigad District have benefitted and 73145 fruit bearing plants have been distributed.

Major Highlights of the Year 2016 - 17:

- ★ For the 2nd consecutive year LOLT Founder & Managing Trustee Mrs. Villy Doctor was recognized as a Change Icon at the Standard Chartered Mumbai Marathon 2017. This year she was the 3rd highest fundraiser and was felicitated by the acclaimed actress & sportsperson Ms. Gul Panag.
- Four Anando Plus beneficiaries ran the Half Marathon at the SCMM 17, of whom, Mr. Swapnil Nalinde, Washim District completed the race in 1 hour 26 minutes.
- Expansion of Project Anando in Maharashtra State in Jalna, Washim, Nandurbar & Raigad Districts with 8 new centers and in Madhya Pradesh State with 1 new centre.
- Kalpataru, a musical presented by LOLT in association with Flowering Tree Inc. and Artscape Production. 25 students under the Anant programme showcased their result which bore testimony to their rigorous music training, under the Anant programme.
- ★ Project Jagruti A new community centre initiated at Kashele, Karjat Taluka, Raigad District in November 2016 to reach out to 40 villages in interior areas.
- Project Jagruti Inaugurated Ankur Demo Plot with 127 fruit bearing plants at Jeevan Asha Community Centre, Tiware - Karjat with support from All Cargo Logistics Ltd & Lions Club of Bombay Queensway.
- ★ Received support from Union Bank of India Social Foundation, to meet the IT needs of the operations team in Karjat & Alibaug Taluka, Raigad District, Maharashtra State.







666 students appeared for SSC examination 2016 – 17 out of which 612 (93%) students successfully cleared the exam, 38 students were unsuccessful and 16 students did not appear for the exam. Out of the 612, overall pass students, 83 students secured distinction, 237 children secured 1st class, 225 secured 2nd class and 67 students secured pass class.

Description: Dinesh is a handicapped child without a left hand. His family is aware that he has good potential but they were not focusing on his academics and schooling. The social worker counselled his parents and made them understand that he has a good future despite the handicap. The social worker shared the examples of 2 teachers who are handicapped and working as Government teachers, of which, one teacher is working in the nearby village. This sharing made the parents more positive about the future of their child, as this would also lessen their problems. On the other hand, Dinesh was made aware of the reservations for the handicap and counselled him as also supported him to resolve the various hurdles before him like - transportation which was resolved by providing him with a bicycle, and making his friends teach him how to ride it. Once he was confident of riding it he was supported in obtaining permission to ride it to school and SFSEP classes. He began attending classes regularly and showed remarkable improvement and furthermore was soon made a leader. His progress is being tracked continuously.

Description: Namrata was enrolled in Project Anando in Std VIII. In this year it was observed that she was suffering due to pain in her joints. Her family is uneducated and have a number of superstitious beliefs, and were refusing to get her treated by a medical doctor, leading to her pain increasing to such a point, that she was unable to walk thus making her homebound, and unable to attend school or any other Anando activities. Both her parents and herself, underwent indepth counseling sessions before they were convinced of getting a doctor's advise on the problem. They were accompanied to the doctor in Alibaug city and with treatment she showed remarkable progress. Her physical strength has returned and she has now started attending school, workshops and SFSEP classes regularly. The social worker continues monitoring her health to ensure her full course of medication is followed and that she is able to attend school without difficulty.

Description: Ajay is a single - parent child. His father expired when he was one year old. After his demise Ajay's mother returned to her father's home where he gave her a room to live in. His mother works as a farm laborer but is weak and thus unable to work regularly. Post Diwali holidays Ajay did not return to school. The social worker visited Ajay's home and understood that he had gone to work with one of his maternal uncles and would return five months later. On realizing that if he did not return he would miss his Std IX exam, his maternal uncle accepted that his mother had made a mistake by sending him in this manner. Despite various efforts by his maternal uncle and the social worker Ajay still did not return to school for many months. The social worker finally connected with his mother, and had a long discussion with her, about the importance of Ajay attending school, and completing at least his basic education. His mother finally agreed to send him back, and hence Ajay returned to school. The social worker is in continuous contact with Ajay to ensure he attends school, the workshop and SFSEP classes regularly and does not drop out once again.

Description: Pintu's parents regularly migrate to Gujarat in search of employment every year as no opportunities exist in their local area. Since Pintu was in Std X this year, the social worker was more alert and began to track their plans in advance. The team started counselling them two months before they migrated and suggested that Pintu stay with relatives after noting the crucial year that he was in. His parents were willing to keep him back but were worried about who would bear his expenses. Part time work was found for Pintu, from which, he would meet his expenses. His relatives were convinced to keep him with a condition, that he would help them in doing their household chores. He was assured of regular contact with his parents through the social worker's cell phone and that he would be able to join his parents as soon as his SSC exam was completed. Pintu & his family made this decision on the advice of the LOLT team and he was able to appear for his SSC exam, without any stress whatsoever. He joined his family post the exam.

- All Anando beneficiaries were provided with a Marathi English pocket dictionary in this academic year as
 part of the education material provided every year with an objective to strengthen their performance in English.
- Nandurbar District
 - The annual cultural event **Bal Kala Mahotsav** was organized for the Anando beneficiaries in Nandurbar District for the first time since its inception in 2009 with full support from parents, school authorities & village authorities.
 - The concept of late night parent meetings at the village level was introduced in Nandurbar to ensure & strengthen support from parents in the Anando intervention.

Student Friendly Supplementary Education Programme (SFSEP)

- Extensive use of Teaching Learning Material (TLM): A wide range of TLM was created by the SFSEP teachers and students together comprising of charts, flash cards, 3D & 2D shapes, puzzles, drawings and much more. This ensured attention, interest and active participation of students leading to academic growth and a boost in self-confidence.

Songs on Maths concepts written and composed by SFSEP teachers, English poems composed in different tunes; singing performances of these English Maths songs, Maths models & exhibition – an event organized by the teachers and students of Khopoli Centre, Khalapur Taluka, Raigad District to create an interest and enthusiasm amongst the children to learn subjects like Maths and English creatively.



• Skills for Adolescents Programme : in collaboration with Lion's Quest - A 3 day residential training program on 'Social and Emotional Learning for Adolescents' was organized for the entire Anando team of 45 social workers and 6 Project Heads at Jeevan Asha Community Centre, Karjat in September 2016.

Anando Plus

Partnered in Alibaug & Washim



This program aims at supporting Anando students post Std X (SSC) to make appropriate career choices based on their aptitude, capabilities and interest either to pursue higher education or undertake vocational training. Efforts are made to network with local educational institutes to give special considerations and/or generate financial support through scholarships for the needy children.

Overall Impact:

Amongst the Anando Plus beneficiaries, who are earning:

- 45.6% earning less than ₹ 5000 per month
- 27.7% earning between ₹ 5001 to ₹ 7000 per month
- 22.6% earning between ₹ 7001 to ₹ 10000 per month
- 04.2% earning more than ₹ 10000 per month

Highlights of the year 2016 -17

- Eight Anando Plus students are now employed at Light of Life Trust 4 in Karjat, 1 in Head Office, 3 as SFSEP teachers in Nandurbar, Jalna & Worli, respectively.

- Vandana Koli from Nandurbar District is an HSC LOLT ranker student. Her family was not able to financially support her higher education. Effective networking by the LOLT team lead to her getting admission in BCA on a freeship.
- Four Anando Plus beneficiaries participated in the Half Marathon at the Standard Chartered Mumbai Marathon 2017 and successfully completed the run of 21 Kms. Mr. Swapnil Nalinde from Washim District ran the 21 kms in 1 hour 26 minutes and was ranked 18th at the event.
- Built strong networks with local business houses/institutions like Tata Power Call Center, medical shops, malls, hospitals, BPO centers etc. for job placement of Anando beneficiaries as per their needs, aptitude, and capabilities.





Highlights of the year:

- Totally 706 beneficiaries were trained through 10 Livelihood Training Programmes offered at the community centre.
- New livelihood training programmes introduced :
 - Unarmed Security Guard Training Course
 - Water Technician Program.
- Inauguration of Jeevan Asha Community Centre in Kashele Village on 17th November 2016.
- Under Bank of India's Star Swarozgar Yojana 92 farmers were trained in goat rearing and vegetable cultivation.
- Renewal of MKCL affiliation for computer training. 75 students undertook MSCIT training in this year through the centres in Tiware & Kadav.
- Setting up of Sewing & Tailoring Unit first order completed of 72 shirts for Pintu Dresses in Karjat.
- Selected women from the jewellery making course have been undertaking job related assignments and now are earning upto ₹ 2000/- per month.

Placement of trained beneficiaries :

- Out of the 80 women trained through the sewing & tailoring programme, 56 women now have their own tailoring machines and have become self-reliant. Six women are working in tailoring shops.
- Six trainees trained through unarmed security guard training programme have been successfully placed. One trainee has been selected for the Fire Brigade Training and one trainee is now working as a Bouncer.
- Out of the 15 trainees who were trained under the health attendant training programme, six trainees have secured jobs at local level.

During the village level health camp conducted in Ambot village she was detected with vision problems in September 2016. She was called to the Lotus Eye Hospital screening camp conducted in collaboration with LOLT's MMU for a screening with the ophthalmologist and was detected with cataract. She lives alone and hence could not undergo the surgery immediately.



The LOLT medical social worker counselled and convinced her to undergo the surgery, as she would be able to see better, as also be able to look after herself better. She was also convinced to stay with her daughter, post the surgery, so that she could be look after. She underwent cataract surgery for her right eye on 13th October 2016. She is ecstatic at getting her vision back, & finds comfort in being independent once again.

Name & AgeMs. Krupali Dyaneshwar Masane 7 YearsVillageAmbot village

Krupali attended MMU's R.Z.P. school health camp on 21st Feb 2015 at Ambot. She was detected with torticollis & was hence referred for surgery & treatment. The LOLT team continuously followed up with the family for over a year, before they decided to take her to the D. Y. Patil Hospital, Nerul, where initially she was given physiotherapy which unfortunately did not show results. Finally they decided



to get a surgical correction done as advised earlier. She was operated on 25thAugust 2016 and she is now able to lead a near normal life.
